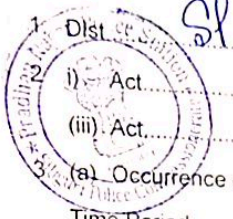

Sir,

In producing here with six arrested accused persons namely 1) Jiban Biswas (42) s/o Lt. Jagadish Biswas of Dasharat Pally Ward No 44 PS-Bhaktinagar, Dist-Jalpaiguri, 2) Amar Das (28) s/o Bindeshwar Das of Pokaijote, Po-Champasari, PS-Pradhan Nagar, Dist-Darjeeling, 3) Sailandra Kumar Yadav (24) s/o Suresh Yadav of Repulatala Bakabalua pS-Hatua Dist-Gopalganj Bihar, 4) Prakash Sharma (30) s/o Pritam Sharma of Champasari, PS-Pradhan Nagar, Dist-Darjeeling, 5) Rajesh Singh (45) s/o Jaylal Singh of Gajipur, PS-Deshan, Dist-Vaishali, 6) Tuntun Yadav (32) s/o Krishna Nand Yadav of Baishan PS- Hatua, Dist- Gopalganj Bihar under arrested U/S 41 Cr.P.C and do hereby I PSI Youel Lepcha lodge a written complaint against them.

In this regard I beg to inform you that on 31.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Siliguri Junction area. I along with C/207 Niladri Sarkar and CV/ 372 Suman Saha had been to Siliguri Junction area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41 Cr PC in between 14:35 hrs to 15:05 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
