Sir,

With due respect I Sri. Krishna Singh, S/o Pramad Singh, of Debidanga Anchal, Champasari, P.S.- Pardhan Nagar, Siliguri, Dist- Darjeeling, would like to draw your kind attention to the following effect that on 30.01.2022, at about 10.30 pm my maternal nephew, Sagar Singh, s/o Rambilash Singh, of Debidanga Anchal, Champasari, P.S.- Pardhan Nagar, Siliguri, Dist- Darjeeling, was brutally assaulted by aforesaid person with blunt object like battam (wooden block) at his face/mouth as a result he sustained grievous hurt by profuse bleeding injury and uprooted his two teeth and face was disfigured near Debidanga bazaar, Champasari i.e., in front of his house, the aforesaid person thought that my nephew was died as a result he fleet away from there, where my said nephew was searching his key of his vehicle, the aforesaid person intention was to kill him after got injury my nephew became senseless after sometimes my elder sister i.e., mother of my nephew searched and got him lying in the field unconscious condition and blood was oozing from his mouth.. Thereafter my elder sister Hara Singh called me and also told everything and after hearing the same I alongwith my relative Puran Mahato immediately rushed there and pick up my nephew in a vehicle and went to Siliguri District hospital, Where in he got some treatment and also got ten stitched (10) by repairing his lip and attending Doctor instructed us to take patient/my nephew to N.B.M.C. & Hospital, therefore we took him N.B.M.C.& Hospital wherein my nephew also got initial treatment and doctor of their instructed us my nephew needs immediate operation, presently we are going to medical college for his surgery. The aforesaid person is furious in nature and habitual offender, previously he also assaulted several persons and have not respect upon law as well as police personal. The photocopy of medical paper of Siliguri District Hospital dated- 31.01.2022 is annexed with this complaint and also annexed the colour photograph of Victim/my nephew.

In view of that you are requested to booked the aforesaid culprit in this case and take appropriate legal steps against him as per law.
