With due respect and humble submission, in producing herewith one arrested accused namely Phanindra Rijal(43) S/O Rewalal Rijal of Utpal Nagar Champasari road ,PS-Pradhan Nagar Dist Darjeeling under arrest along with following seized articles under proper seizure;

- i)15(Fifteen) bottles of Kingfisher Strong Premium Beer each bottle contains 650 ML.
- ii)08(Eight) Bottles of Premium Tubrog Beer each bottle contains 650 ML.
- iii) 04(Four) Bottles of Black Label Strong Beer each bottle contains 650 ML.
- iv) Four used bottles of different brand whisky.

I ASI Tarun Kranti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 31.01.2022 when I along with CV/645 Pankaj Gupta,CV/223 Swapan Chhetri were performing Special van duty vide PDN PS GDE NO 1691 dtd 31.01.2022.I received an information that one person namely Phanindra Rijal has storage huge quantity of illegal liquor in his Hotel styles as "Gulma Dhaba"at Milon More,PS-Pradhan Nagar Dist Darjeeling and selling the same from Hotel. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid at his house and detained the above noted person and on search recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 21:30 hrs 22:45 hrs and I arrested him after maintaining all formalities regarding arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Phanindra Rijal(43) S/O Rewalal Rijal of Utpal Nagar Champasari road ,PS-Pradhan Nagar Dist Darjeeling and arrange for its investigation.
