Sir,

With due respect and humble submission, in producing herewith one arrested accused namely Surya Das(45) S/o Lt. Kisto Mohan Das of Paschim Dhantala, Fulbari PS NJP Dist Jalpaiguri under arrest along with following seized articles under proper seizure;

i) 21(Twenty) bottles of Himalayan Gold country Spirit 60*up each bottle contains @ 300 ml each.

ii) 10(Ten) Bottles of Starling Reserve Whisky each bottle contains 180ML.

iii) 07(Seven) Bottles of Imperial Blue Whisky each bottle contains 180ML.

I ASI Asit Singha of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 31.01.2022 when I along with CV/128 Ajay Sahani, CV/242 Rakesh Mangar were performing Special van duty vide PDN PS GDE NO 1691 dtd. 31.01.2022. I received an information that Liquor is being sold illegally from Mohanto Hotel situated near Regulated market gate no-1, under PS Pradhan Nagar. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid at the Hotel. Seeing Police Party owner of the Hotel namely Debu Mohanto S/o Amal Mohanto of Samar Nagar Ganesh Ghosh Colony fled away from the hotel. However we could manage to detain the above noted person and on search recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. On interrogation he stated that He along with Hotel owner Debu Mohanto selling the same from Hotel since long for their wrongful gain. Accordingly, I seized & label the above noted articles in between 22:40 hrs 23:25 hrs and I arrested him after maintaining all formalities regarding arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Surya Das(45) S/o Lt. Kisto Mohan Das of Paschim Dhantala, Fulbari PS NJP Dist Jalpaiguri and arrange for its investigation.
