In this regard I beg to inform you that on 01.02.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/999 Mithu Chandra Roy and C/ 135 Sanjib Oraon had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19.
