Sir,

In producing here with six arrested accused persons namely 1) Sunil Tamang (280 s/o Sankar Tamang of Sishufangi Milan more PS-Pradhan Nagar, Dist-Darjeeling, 2) Mantosh Mondal @ Lal Babu Mondal of Regulated Market, Ward No 46, S.M.C PS-pradhan Nagar, Dist-Darjeeling, 3) Suman Bej (24) s/o Biswnath Bej of Gangajal Ghat PS-Gangajal Ghat Dist-Bankura 4) Pritam Dey (260 s/o Gopal Day of Joynagar, Ps-Jaynagar Dist-South 24 Parganas, 5) Raju Das (22) s/o Jyotish Das of Bho;apata PS-Tufanganj dist-Coochbehar under arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to inform you that on 01.02.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/999 Mithu Chandra Roy and C/ 135 Sanjib Oraon had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41 Cr.P.C in between 15:45 hrs to 15:55 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
