I PSI Sumit Sarkar of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 01.02.2022 when I along with ASI Ashit Singha CV/223 Swapan Chhetri, CV/242 Rakesh Mangar were performing Special drive duty vide PDN PS GDE NO 1735 dtd. 01.02.2022.I received an information that one Ajay Gurung of Maheshmari under PS Pradhan Nagar sells Sikkim liquor illegally from his house .Accordingly, I share the information to you and as per your kind instruction myself along with officer and force rush to the spot and held raid at his house. On search of his house recovered above noted liquor, On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. On interrogation he stated that he brought the liquor from Sikkim for selling the same for his wrongful gain. Such liquor is for sale Sikkim only and also non duty paid to Govt. of West Bengal. Accordingly, I seized above noted liquor & prepared label the above noted articles duly signed by the witnesses. Seizure was done between 15:25 hrs 16:40 hrs and I arrested him after maintaining all formalities regarding arrest.
