Sir,

In producing here with four arrested accused persons namely) Debasish Dey(26) s/o Lt. Shankar Dey of Shanti Nagar, Dabgram, Asghigarh PS Bhaktinagar Dist Jalpaiguri 2) Rahul Roy (24) s/o Jitendra Roy of Rajendra Nagar Colony PS Pradhannagar Dist Darjeeling 3) Md. Safik Alam (21) s/o Md. Jamshed Alam of Vivekananda Nagar, Koyla Depot Ward No 7 PS Siliguri Dist Darjeeling 4) Jay Narayan Roy (42) s/O Pankaj Roy of Gurung Busty upper road, PS Pradhannagar Dist Darjeeling under arrested U/S 41 Cr.P.C and do hereby I ASI Prabal Sarkar lodge a written complaint against them.

In this regard I beg to inform you that on 02.02.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/559 Raju Poddar and CV/ 880 Shyamal Dutta had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41 Cr PC in between 16:15 hrs to 16:45 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
