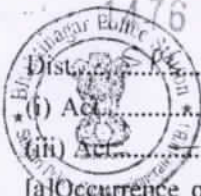

I Smt. Aparna Das, Wife of Sri. Madan Mohon Das, resident of Rabindra Nagar, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, would like to draw your kind attention to the following effect that in the year of 1995, I purchased a land measuring about 2 kathas 4.5 chattak of land recorded in R.S Khatian numbers 200/13, L.R. Khatian No. 167 R.S Plot No. 180/790 and L.R. Plot No. 76 mouza-Dabgram from Sri. Sahadeb Ghosh, son of Late Krishna Chandra Ghosh, vide registered deed no. I-1577 dated 10.04.1995 registered in the year 1995. Thereafter the aforesaid land was mutated by the concerned authority in my name. I along with my husband regularly visited our land but day before yesterday I come to know that few persons are trying to constructed boundary with tin with the help of local hooligans, then an then I along with my husband and our friends reached in to our land but we found none of their and we trying to remove the tin, suddenly one smt. Mamota Roy, wife of Sri. Larkeswar Roy (known as Babla Sabjiwala) and her daughter (name is unknown) came to the spot and demanded our land as their land, and also for their support other local persons namely 1. Pradip Karmakar, son of Manoj Karmakar, 2. Mohim Roy, Son of late. Digen Roy, 3. Bhobotosh Roy, Son of Anil Roy, 4. Vijay Roy (father's name unknown) gathered there and they supported that lady (Mamota Roy) and they shouted with filthy languages, when we demanded their papers regarding their claim, they did not show us any valid papers regarding their claim/ land.

The above named people threatened us if we again claim our land or visit our land they will destroy us to every extent.

Finding no other alternatives I rush to the Police station for their assistance and the police suggested me that I should file one written complaint along with my entire relevant document related to my land before the police station, being a lady is unable to look after or faced this short of problem regarding my land, I need Your cooperation

In view of premises you are requested to investigate the matter properly and punish them as per law.
