I Sri Shubhamoy Roy S/O Lt. Shekhar Roy resident of Rajib Gandhi Street Dabgram, ward No. 23 under S.M.C., P.O. Rabindra Sarani, P.S. Siliguri Dist. Darjeeling do hereby acknowledge you that 1. Pranab Mandal S/O unknown & 2. Prasenjit Mandal S/O Pranab Mandal resident of Rajib Gandhi Street, Dabgram, ward No. 23 under S.M.C., P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling are my neighbor and they are known as land grabber in our locality also reside at our adjacent land of our above mentioned address. These two people are constructed an illegal construction at my / our boundary of land and for that me and my family members raised objection. Subsequently I inform to the Siliguri Municipal Corporation for such illegal construction and the concern authority took step and given notice to the above mention goons vide Memo No. 177/SMC/N/Bldg/2020-2021, dated 16-12-2020 for abolish the illegal construction. But they did not comply such order.

On 28-01-2022 at about 14:00 to 14:30 hrs. the above mentioned goons again started such illegal construction and subsequently my mother namely Smt. Mamata Roy W/O Lt. Shekhar Roy opposed them and raised objection for such illegal construction. At that time one Prasenjit Mandal S/O Pranab Mandal hit my mother with bamboo and fist and blow. After that my mother fall down with serious injury, at that time another goon Pranab Mandal pull my mother with fist of hair. My mother was highly injured and got bleeding from many parts of her body. Suddenly I came to that place and risqué my mother. Those antisocial also threaten me that If we go to the police they will kill us at any cost.

After that I admitted to my mother at Siliguri Dist. Hospital immediately but the Hospital authority referred my mother at Nursing home of better treatment. Now my mother is being admitted at Mitra Nursing Home with highly life risk and injury.

For that I am begging before you to take appropriate step and arrest such antisocial 1. Pranab Mandal, 2. Prasenjit Mandal of Rajib Gandhi Street, Dabgram, ward No. 23 under . S.M.C. P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling for the sake of Justice.
