Sir,

In producing herewith three (03) arrested persons who disclosed their identities namely (1) Fate Ali (46 yrs) S/O Late Farman Ali of 466/81 Thakurganj Chowk, Pibokkhara, P.O- Konisbar Chowk, PS- Thakurganj, Dist- Lucknow (Uttar Pradesh), (2) Sahil Ali (34 yrs) S/O Salim Ali of do (Uttar Pradesh), and (3) Sajjad Ali (50 yrs) S/O Mahabbat Ali of Mehmadabad, Sangat Pela near Hunuman Mandir, PS- Ranakunda Chowrah, Dist- Sitapur (Uttar Pradesh) along with the following seized articles, seized under proper seizure list, duly attached herewith viz:

- i) One (01) Carton box of "Altorex-CD" Cough Syrup (Chlorpheniramine Meleate & Codeine Phosphate Syrup) containing 50 bottles @ 100 ml each wrapped with brown Cello tape marked as Exhibit-A having batch no. ML-4210,
- ii) Two bottles of "Altorex-CD" Cough Syrup (Chlorpheniramine Meleate & Codeine Phosphate Syrup) containing 100 ml each taken as sample from the exhibit-A and marked as Exhibits-A1,
- iii) One Motor Cycle (Honda Unicorn) having display no. BR-01BE-9917 marked as Exhibits-B
- iv) One Motor Cycle (Apache RTR) having display no. BR-04AG-4542 marked as Exhibits-C

I, SI Uday Chakraborty of Siliguri-PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against (1) Fate Ali (46 yrs) S/O Late Farman Ali of 466/81 Thakurganj Chowk, Pibokkhara, P.O- Konisbar Chowk, PS- Thakurganj, Dist- Lucknow (Uttar Pradesh), (2) Sahil Ali (34 yrs) S/O Salim Ali of do (Uttar Pradesh), and (3) Sajjad Ali (50 yrs) S/O Mahabbat Ali of Mehmadabad, Sangat Pela near Hunuman Mandir, PS- Ranakunda Chowrah, Dist- Sitapur (Uttar Pradesh) to the effect that today ie on 29.01.22 at 14.25 hrs I have received a specific source information that three persons would come with huge quantity of Cough Syrup with a two Motor Cycle having display nos. BR-01BE-9917 & BR-04AG-4542 respectively at Jalpaimore Bus stand area from Fulbari side for their wrongful gain. The matter has been diarized vide Siliguri PS GDE No. 1785 Dt- 29.01.22. Accordingly, I informed the matter to Sri Sudip Chakraborty, Inspector-in-Charge, Siliguri Police Station, SPC in writing a letter to him and expressed the entire information, accordingly he directed to me to work out the information immediately. Hence at about 14.45 hrs as per his kind direction myself along with ASI Dhruba Misra, ASI Siben Sarkar, ASI Subir Sen, CV/283 Prosenjit Dey and CV/622 Ramanth Barman all of Siliguri Police Station, Siliguri Police Commissionerate left for Jalpaimore Bus Stand area to verify the veracity of the information vide M C C. No. 326/22 Dt. 29.01.22 which refers to GDE No.1788 Dt. 29.01.22 by Govt. Vehicle No. WB 61A0137 driven by CV/285 Krishna Yadav. Due to shortage of time and there was very chance to miss the information, hence, I could not able to obtain search warrant

At the time of departure from PS, I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc. At about 14.55 hrs we reached at nearby Jalpaimore Bus stand area & kept our vehicles at a distance. Subsequently we called two independent witnesses namely; (1) Santosh Pandey (34 yrs) S/O Late Bhagwan Pandey of Santoshi Nagar, Ward No. 05, PS- Siliguri Dist- Darjeeling (2) Pradip Mahato (30 yrs) S/O Sri Dilip Mahato of do and disclosed our identities and informed them about the information in hand and requested them in writing to accompany us to witness the Police action. They agreed & gave in writing about their consent to accompany Police during the raid.

Then, as per source information, we approached towards Jalpaimore bus stand area near Statue of Binoy, Badal, Dinesh & as per identification by source I managed to cordoned the place and found that the above noted three persons stopped their above noted Motor Cycle and got down from the mentioned Motor Cycle and both of them started carrying the Carton box holding jointly towards Passenger Waiting room, Jalpaimore under Siliguri PS. We detained three of them, who were carrying jointly the said-Carton box.

After disclosing our identities, in presence of independent witnesses we had a strong reason to believe that the detained persons were carrying contraband Cough Syrup in their exclusive joint possession & trying to supplying/ selling the same in the area for their wrongful gain. On being asked they disclosed their identity as noted

above and admitted that they possessed Cough Syrup. Then I gave them option in written whether they wanted to be searched in presence of Executive Magistrate or any Gazetted Police Officer. They agreed to be searched by one of them. Further, I served them option notice in accordance with provisions of law in this regard in writing and they also gave their approval of being searched by any one of them in writing on the notice served to them. Then I informed the matter to I.C. Siliguri PS & I requested him to come at Jalpaimore Bus Stand area near Passengers Waiting room to remain present and supervise the search, seizure and label being a Gazetted Police officer. Accordingly, at 16.15 hrs Sri Sudip Chakraborty, I. C. Siliguri PS arrived at the spot in uniform and disclosed his identity to the detained persons as well as to the witnesses as a Gazetted Police Officer. Then after, I also offered the independent witnesses and the accused persons to search our Police Party as per provision of law. But they refused to search the police party. Under supervision of Sri Sudip Chakraborty, Inspector -In-charge, of Siliguri Police Station, SPC and in presence of two independent and dis-interested public witnesses, I therefore searched the detained persons following all formalities keeping their decency but nothing could be recovered on their persons except their wearing apparels. Then, I opened the one carton box and found that the above seizure articles kept concealed in the said carton box. Then all detained persons confessed that they were carrying these carton box in concealed manner for selling/supplying to young boys under Siliguri and its adjacent area. On demand in presence of the Gazetted Police Officer, Sri Sudip Chakraborty, I. C. Siliguri PS, they failed to produce any valid document in support of possessing of the said contraband Cough Syrup carton which was holding by them jointly.

Accordingly I counted the said Cartoon containing Cough Syrup, which was found in joint possession of the above noted detained persons and found total 50 bottles of "Altorex-CD" Cough Syrup (Chlorpheniramine Meleate & Codeine Phosphate Syrup) containing 100 ml each marked as Exhibit- A, and also collected two bottles of said Cough Syrup containing 100 ml each as sample taken from Exhibits A and marked as Exhibits A1. Then, I seized the above noted articles under proper seizure list and labeled, duly signed by the above noted witnesses, Police personnel and the Gazetted Police Officer, Sri Sudip Chakraborty and duly acknowledge by the detained two persons. I also supplied a copy of seizure list to all the detained persons. The whole search, seizure & label was made in between 17.35 hrs and 19.05 hrs. In the mean time, suddenly the above noted three detained persons started to flee away from the spot. After hot chase, a scuffling took place in between the detained persons and our police party causing minor injury on their police personnel. After that, on further asked the apprehended persons confessed in presence of Gazetted Police Officer, Sri Sudip Chakraborty, I.C Siliguri PS and other witnesses that they procured the said seized Cough Syrup from Fulbari side for the purpose of illicit gain. On interrogation they disclosed that they had been dealing in such business of selling the said Cough Syrup illegally since long. Then I arrested the above noted accused persons after observing all guidelines of Apex court

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely: (1) Fate Ali (46 yrs) S/O Late Farman Ali of 466/81 Thakurganj Chowk, Pirbokkhara, P.O- Konisbar Chowk, PS- Thakurganj, Dist- Lucknow (Uttar Pradesh), (2) Sahil Ali (34 yrs) S/O Salim Ali of do (Uttar Pradesh), and (3) Sajjad Ali (50 yrs) S/O Mahabbat Ali of Mehumadabad, Sangat Pela near Hunuman Mandir, PS- Ranakunda Chowrah, Dist- Sitapur (Uttar Pradesh)


