I Smt Pinki Ram wife of Late Ranjit Ram, Hindu by faith, private service by occupation, resident of Vivekananda Nagar, near Rail Line, P.O. & P.S. Siliguri, Ward No. VII of Siliguri Municipal Corporation, Dist. Darjeeling would like to submit you that on 28-01-2022 I along with my mother and my daughter went to North Bengal Medical College & Hospital for the purpose of our treatment.

That at about 4/4:30 P.M. I along my mother and daughter return home from there and when I entered into my house I notice that some portion of my wooden wall of my room was broken, thereafter I asked my brother named Pintu Das who broke the wooden wall of my room as because he was in the house "" but he answered that "he does not know" thereafter I asked my neighbour about the broken wooden wall but they sated that they did not know nothing who broke the wooden wall of my room.

Received on 29/1/22 at 20.55 hrs. vide SCG PS GDE NO. 1804 dt. 29.1.22 Started SCG PS Case No. 155/22 dt. 29/01/22 u/s 380 g.p.c.

That at evening time I noticed that my show case with Almirah's lock was open then I searched my show case with almirah, I found that my golden jewellerys, i.e Golden ear Jhumka, 4 piece of golden nose ring, one golden finger ring, and one golden locket of Mangal sutra, one golden ear rings, some pieces of gold, 4 nos of golden Bala were missing from my said almirah thereafter again I asked my said brother that whether any one entered into our room in my absence but he did not give any satisfactory answer.

Sir, i am a poor widow I and my minor daughter have been staying in the said room I Kept the said golden jewellerys for the future of my daughter but I have doubt that my brother Pintu Das has stolen away above mentioned jewellerys from my Almirah as because He was only in the house when we went to N.B.M & C. no other members were present at my house. I, therefore request you please look into the matter and take necessary action as early as possible and help me to find out my golden jewellerys.
