Sir,

With due respect I Primod Kr Kalwar, S/o-L.T-
Ganga Kalwar Permanent resident of darbhanga
to 6 ward No-6- Siliguri, Darjeeling, would
like to inform you that we had an issue
regarding land with our neighbours, namely
Manoj Prasad Sah and his younger brother
Pappu Shah since last 13 years around, for
which yesterday on 29/01/2022 we got the
order from court in our favour of possession
for which all the necessary works were done
by the representative of court which followed
by us, therefore by today 30/01/2022 around
4pm one of his brother Pappu Shah found
my son ayush aged 6 1/2 years playing in his
boundary for which he assaulted my son
very badly scratching and pressing on
neck forcibly for which he was suffocated
for while later we came to know the matter
by my son ayush while we found him crying
for which we went to talk to Pappu Shah
he was badly drunk and threatened us
to punish the same if he find us alone,
therefore I request your kind action towards the
matter as we are worried the same incident
may happen again.
