
Sir,

With due respect, I PSI Lawang Bomzon of Bagdogra PS, do hereby lodge this written complaint against the following arrested persons namely i) Devesh Dutta Thakur 56yrs s/o Late Naresh Dutta Thakur of Lala Busty PS, Bagdogra Dist, Darjeeling ii) Tej Bahadur Lakra 25yrs s/o Silbinush Lakra of Kadopani TE, PS, Bagdogra Dist, Darjeeling iii) Edit Ekka 27yrs s/o Late Liusus Ekka of Kadopani PS, Bagdogra Dist, Darjeeling iv) Rohan Toppo 22yrs s/o James Toppo of Kadopani PS, Bagdogra Dist, Darjeeling to violate Government of West Bengal order vide order No. 753/XVII-ISS-22/2020 dated 02.01.2022.

The facts of the case in brief is that today on 08.01.2022 in course of K-35 evening Mobile van duty along with force vide Bagdogra PS, vide GDE No 883 Dtd, 08.01.2022 in between from 14.25 hrs to 14.45 hrs the above noted persons were roaming at Panighata More area in casual attitude also they all are did not wearing Face mask to violating the restriction measures issued by the Government of West Bengal. I repeatedly cautioned and warned them to wear face Mask but they did not listen rather showed negligent and casual attitude and their unlawful movement likely to spread COVID -19 dieses which is dangerous to life also recently high rate of infectivity and multiple cases of a new COVID-19 variant "Omicron", in addition to restriction and relaxation measures as already in force. Finding no other alternative way to save people and restraint the disease not to spread others the above mentioned persons could be apprehended. On interrogation, they all disclosed their names and address as noted above. On further asked, they all admitted that they all were aware of the order to wear facial Mask in public place. As they had violated the order of State Government of WB vide order No 753/V-ISS/2M-22/2020 Dated 15.12.2021 and earlier orders promulgated to contain the spread of Covid-19 virus. Therefore, they were arrested and brought to Police Station and put in Police Custody.

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law.
