Sir,

In producing here with the one accused person namely Birju Sahani (61) s/o late Kuldip Sahani of Prakash Nagar, ward No. 43, Near Military Ghat, P.S Bhaktinagar, Dist. Jalpaiguri along with following seized articles as per proper seizure list:

1. Fourteen(14) Bottles of Himalyan Gold 60 UP Country Spirit each bottle containing 600ml.

I, PSI Sailesh Subba of Bhaktinagar PS under Siliguri Police Commissionerate lodged this written complaint against the above noted accused person to the effect that on 04.02.2022 while performing special raid duty received a source information that the above noted accused person has possessed huge amount of Liquor at his Tea shop situated at Prakash Nagar, Near Military Ghat under Bhaktinagar PS for selling the same to the local customers. This refers to BKN PS GDE No. 214, Dt. 04.02.2022. Accordingly the information share before you and as per your kind direction myself along with ASI Dipak Karmakar, Constable C/762 Mujibul Rahaman, CVF-014 Labanyamoy Barman headed towards Prakashnagar to verify the veracity of the information. At about 19.35 hrs we reached at Prakashnagar, near Military Ghat and held raid at the shop of the aforesaid accused person and apprehend him and searched his shop and recovered above noted seized articles. On enquiry the apprehended person admitted his guilt and stated that he has been storing the liquor for the purpose of selling to the local customer since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 19.55 hrs to 20.10 hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Birju Sahani (61) s/o late Kuldip Sahani of Prakash Nagar, ward No. 43, Near Military Ghat, P.S Bhaktinagar, Dist. Jalpaiguri under proper section of law and arrange for its investigation.
