It is further mentioned here that he also fraudulently collected photo of my ATM Card bearing Card No. 4591 5600 8625 3416 VISA SBI through WhatsApp. Practically he quit my bank balance left only Rs. 899.48

In view of the above, it is requested to diarize the above facts and necessary steps may kindly be taken to recover the above amount.
