Subject: Report against burglary and theft at residence situated in Kawakhari, near Medical More.

Sir,

I would like to inform you that a grave burglary has taken place in our residence located at Kawakhari, near Medical More.

On account of my present placement as Deputy Director, Food and Supplies Department, Government of West Bengal in Khadya Bhavan, Kolkata, our entire family stays at Kolkata. As a result no one was residing in this home from past one and half year. Although, the home was in proper condition at the time of last visit of my sister Smt. Mamata Baraily on 22nd Oct. 2021.

We came to know about the incident through one of our acquaintances Sri Parimal Roy (Mob No. 9563164419) who informed about it to my sister, Smt. Mamata Baraily (Mob No. 9434328959) over mobile phone yesterday in the morning at about 10:30 am. Upon hearing about the incident from my sister, I came to Siliguri yesterday at 4:00 pm. Sri Parimal Roy was informed of the incident by our neighbor Sri Sandip Dutta (Mob. No. 9434006900) who had in the past 1-2 days seen a person in the morning time carrying goods covered in bed sheets from our home, who fled on his interrogation on 3rd Feb. 2022 about his movement. Sri Dutta has told me that he can identify the burglar if he is shown up to him.

On arriving at our residence, I found that the miscreant had committed burglary by breaking open and then removing the collapsible iron gate at the rear portion of the residence. All the articles as listed below have been stolen from our home and it has been completely ransacked:

1. Collapsible iron gate stated above.
2. Sony Television Set.
3. Computer and Printer.
4. Bose Music System.
5. Thomson and Sony CD Players.
6. Gold Ring-5, Gold necklace-2
7. Rolex, Rado and Titan gents' wrist watches.
8. Utensils and vessels made of copper, bronze, steel and aluminium.
9. 2 No. of LPG Cylinder and 2 No. of LPG Oven.
10. Pressure cookers, rice cookers.
11. Clothes and briefcase containing important documents including my Scheduled Caste Certificate.
12. Suitcases.
