I, SI Susanta Dhar of Matigara PS SPC to the effect that on 06.02.2022 while performing SPL Mobile duty under Matigara PS area found four persons namely (i) Dipankar Sarnakar (32), S/O Haripada Sarnakar of Itahar, PS - Itahar, Dist- U/Dinajpur, (ii) Koushik Ghosh (20), S/O Kartick Ch. 
