With due respect and humble submission, in producing herewith one arrested accused namely Prakash Das(32) S/O Prafulla Das of Basguri, P.S-Pundibari, Dist.Coochbehar under arrest along with following seized articles under proper seizure;

**i) 11(Eleven) bottles of Himalayan Gold country Spirit 60\*up each bottle contains @ 600 ml each**

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 04.02.2022 when I along with CV/645 Pankaj Gupta, CV/223 Swapan Chhetri were performing Special van duty vide PDN PS GDE NO 126 dtd 04.02.2022, I received an information that one person namely Prakash Das has storage huge quantity of illegal liquor in Hotel at Regulated Market, near Fish market PS-Pradhan Nagar Dist Darjeeling and selling the same from Hotel. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid in the said hotel and detained the above noted person and on search recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 17.45 hrs to 18.15 hrs and I arrested him after maintaining all formalities regarding arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Prakash Das(32) S/O Prafulla Das of Basguri, P.S-Pundibari, Dist.Coochbehar and arrange for its investigation.
