With due respect and humble submission, in producing herewith one arrested accused namely Ram Chandra Paswan(52) S/o Lt. Ram Lal Paswan of Ramkrishna Colony-2 Near Commissioner office PS Matigara Dist Darjeeling under arrest along with following seized articles under proper seizure;

- i) **08(Eight) bottles of Himalayan Gold country Spirit 60*up each bottle contains @ 600 ml each**
- ii) **04(Four) Bottles of Emboss Fine Whisky each bottle contains 750 ML.**

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 05.02.2022 when I along with CV/645 Pankaj Gupta, CV/223 Swapan Chhetri were performing Special van duty vide PDN PS GDE NO 168 dtd 05.02.2022, I received an information that one person namely Ram Chandra Paswan standing at Darjeeling more, under Pradhan Nagar PS with liquor and selling the same to the customer illegally. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and held raid and detained the above noted person and on search recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 18.50 hrs to 19.35 hrs and I arrested him after maintaining all formalities regarding arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Ram Chandra Paswan(52) S/o Lt. Ram Lal Paswan of Ramkrishna Colony-2 Near Commissioner office PS Matigara Dist. Darjeeling and arrange for its investigation.
