Then my worker call me and said all the matter's by phone, and I coming within 10 minutes at the spot. then they trying to fight with me, and I was very scared that time I called police at that place.

And then police van came at place and scolded them, even they not let to permission to me to work that place at my house.

Then on 05/02/22 around 05:10 P.M. all defendant again attacking me and tell me to stop said work, when I was not to response them, then they attacking me with Iron rod, sword, knife etc.

I was badly injured at that time ^{was} senseless for 10 minutes and bleeding ^{From my nose & head} very badly. It was life & death toll attack. then after coming ~~my~~ sence my neighbour take me to hospital and there I was admitted, before I going to hospital I called police and police ~~was~~ saying to go for hospitalized.

So therefore I request to you that please note to this fact at your record book & do what need full.
