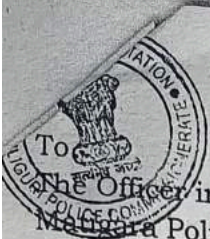

Ram Deo Shaw of Purba Dhantala, Dabgram, PS - NJP, Dist- JPG, (iv) Roshan Biswakarma (19), S/O Dhan Bdr. Biswakarma of Goyal Jote, Nemai, PS - MTG, Dist - DJG arrested u/s 41 Cr.P.C.

I, SI Krishna Ch. Mandal of Matigara PS SPC lodged a written complaint to the effect that on 09.02.2022 while performing SPL Mobile duty under Matigara PS area found Four persons namely (i) Amit Gurung (22), S/O Lt. Belbahadur Gurung of Medical More, PS - MTG, Dist- DJG, (ii) Pukar Biswakarma (21), S/O Ratan Biswakarma of Do, (iii) Arjun Shaw (40), S/O Lt. Ram Deo Shaw of Purba Dhantala, Dabgram, PS - NJP, Dist- JPG, (iv) Roshan Biswakarma (19), S/O Dhan Bdr. Biswakarma of Goyal Jote, Nemai, PS - MTG, Dist - DJG were loitering near City Centre under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Biswakarma of Goyal Jote, Nemai, PS - MTG, Dist - DJG pur under proper section of law and arrange for its investigation.
