Sir,

In producing herewith one lady accused person namely SUSHILA CHHETRI -40YRS W/O LT SHRIMAAN CHHETRI OF KHOLACHAND FAPRI, PO SALUGARA PS BHAKTINAGAR DIST JALPAIGURI along with the following seized articles as per proper seizure list:

1. 09 (Nine) pet Bottles of TIGER XXX RUM each bottle containing 750 ML Blended and bottled by KANCHANJUNGA DISTILLERIES & LIQUORS.
2. Two bottles of SIKKIM SUPER XXX RUM each bottle containing 750 ML Blended and bottled by KANCHANJUNGA DISTILLERIES & LIQUORS.
3. 24 (Twenty four) bottles of ROYAL BLUE WHISKY each bottle containing 180 ML Blended and bottled by KANCHANJUNGA DISTILLERIES & LIQUORS.
4. 12 (Twelve) bottles of ROYAL BLUE WHISKY each bottle containing 375 ML Blended and bottled by KANCHANJUNGA DISTILLERIES & LIQUORS.
5. 05 (Five) bottles of OLD MONK Deluxe Rum each bottle containing 750 ML Blended and bottled by KANCHANJUNGA DISTILLERIES & LIQUORS, South Sikkim.
6. 24 (Twenty four) bottles of ROYAL BLUE WHISKY each bottle containing 750 ML Blended and bottled by KANCHANJUNGA DISTILLERIES & LIQUORS Which was packed in different paper cartoons and kept in the house of Sushila Chhetri.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one SUSHILA CHHETRI -40YRS W/O LT SHRIMAAN CHHETRI OF KHOLACHAND FAPRI, PO SALUGARA PS BHAKTINAGAR DIST JALPAIGURI to the effect that on 07.02.22 at 14.20hrs received a source information from Kholachand Fapri under Bhaktinagar PS that one lady namely Sushila Chhetri has gathered huge quantity of liquor in her house at Kholachand Fapri under Bhaktinagar PS for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-352 dated 07.02.22. As per your kind instruction myself along with force and Lady Police personal proceeded to the PO to work out the information. At 14.50 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from her possession. During local enquiry it came to learn that she is selling the same in open market since long for her wrongful gain without any valid documents/license. In

presence of witnesses I seized the above noted articles from her possession after prepared proper seizure list and arrested her after maintaining all decency & formalities. (The seizure was made in between 15.10 hrs to 16.20 hrs)

I therefore request you a specific case may kindly be started against the accused person namely SUSHILA CHHETRI -40YRS W/O LT SHRIMAAN CHHETRI OF KHOLACHAND FAPRI, PO SALUGARA PS BHAKTINAGAR DIST. JALPAIGURI under proper section of law and arrange for investigation .
