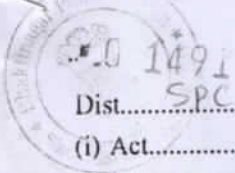

Sir,

In producing here with the one accused person namely Chewang Pincho Sherpa (56) s/o Gyalchen Sherpa of Salugara, Pipeline, Near Salugara High School, Ward No.42, PS Bhaktinagar, Dist. Jalpaiguri with following seized articles as per proper seizure list:

1. Thirty Six(36) Bottles of ROYAL BLUE Premium Whisky each Bottle containing 750 ml.
2. Thirty Six(36) Bottles of ROYAL BLUE Premium Whisky each Bottle containing 375 ml.
3. Fourty (40) Bottles of ROYAL BLUE Premium Whisky each Bottle containing 180 ml.
4. Thirty (30) Bottles of KINGFISHER STRONG Premium Beer each Bottle containing 650 ml.
5. Twenty Four (24) Bottles of HIT Beer each Bottlle containing 650 ml.
6. Twelve (12) Bottles of Old Monk Deluxe Rum each bottle containing 750 ml.
7. One Morello Colour ENDEAVOUR BS-III four wheeler Vehicle bearing Registration No. WB74P 0888 and Engine No. 9P2173.

I, PSI Sailesh Subba of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person to the effect that on 07.02.2022 at around 20.05 Hrs received a source information that the above noted accused person has possessed huge amount of Liquor at his house at Salugara, Near High School Sevoke Road under Bhaktinagar PS for suppling the same at Salugara Bazaar. This refers to BKN PS GDE No. 362, Dt. 07.02.2022. Accordingly the information shared before you and as per your kind direction I along with ASI Dipak Karmakar, Constable C/762 Debraj Biswas, CVF-014 Labanyamoy Barman and CVF-619 Dharmendra Roy headed towards Salugara to verify the veracity of the information. At about 20.20 Hrs we reached at Salugara near Pipe Line and I along with my team held raid at the said House and apprehended one person. On being asked the apprehended person disclosed his identity as Chewang Pincho Sherpa (56) s/o Gyalchen Sherpa of Salugara, Pipeline, Near Salugara High School, Ward No.42, PS Bhaktinagar, Dist. Jalpaiguri. Further maintaining his decency and observing all formalities searched and recovered huge amount of above noted seized liquor from his House and from the above noted seized Vehicle parked at the compound of his House. On enquiry the apprehended person admitted his guilt and confessed that he has been storing the recovered liquor at his house for the purpose of transporting and selling to the local customer since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 20.55 hrs to 21.35 hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.
