And after paid this amount they are charge me again for more money and they told me if you will give me Rs. 48,000/- again then we would credit Rs.12,00,000/- to your account through cheque being No."138377" by Yes bank Limited. I have also paid this money to Human Rights Forum Of India (RBL) bank's account being number 409000909951, IFSC Code is RATN0000236 for clearance of cheque. They are pressure me more money for cancel this project. And they are doing me mentally tortured by phone call still now. I have total paid to them amount is 96,000/- till date.

Therefore I request you to take necessary steps to whatsapp/page/Block/find out the culprit and oblige.
