Respected Sir,

I am Dinamoy Talukdar, S/O Late. Gyanendha Chandra Talukdar, Resident of 360/1, Rashtat Sahani, Rabindra Nagar, Ward-21, Siliguri would like to report you and lodge an FIR with an incident of an assault using bouldar while standing and talking with my two Sister-In-law 1) Miba Sabkar & 2) Aparna Roy, in front of my house, at 4.45 PM on 31-01-2022, by Niral Roy (brother In-Law by relation; S/O Janku Roy, Rabindra Nagar). He spotted us and was staring at us when we looked at him he charged at us and passed by pushing me away and uttered "I will hit you with shoe" towards Aparna Roy. When I protested he tried to hurl punch at me which I dodged away and then pick up a brick to hit me then the locals arrived and intercepted him. He previously hit me with a bottle and several time threatened me to kill. He holds grudge regarding the year-old undivided property dispute and was claiming to sign it, and my Sister-In-Laws. In this situation we are worried because this could end up in more serious consequences, so I am requesting you to take appropriate action.
