Sir,

In producing herewith arrested accused person namely Sadananda Barman (67 yrs) S/O Late Sudhir Barman of Patiramjote, Kalabusty near Radha Krishna Mandir, PS- Matigara, Dist- Darjeeling along with seized articles vize- i) 20 (Tweenty) sealed Bottles of 80 up Pet Himalayan Tuk Tuk country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 50 each (Amounting of Rs 50/- x 20 =RS.1000/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list.

I, ASI Subir Sen of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Sadananda Barman (67 yrs) S/O Late Sudhir Barman of Patiramjote, Kalabusty near Radha Krishna Mandir, PS- Matigara, Dist- Darjeeling to the effect that on 01.02.22 at 15.25 hrs acting on secret source information that the above noted person was busy to sale Id liquor illegally at his temporary shop situated at Jalpaimore area, Ward No. 05, under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 41 dated 01.02.22 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with CV-283 Prosenjit Dey and CV-662 Ramanth Barman left for Jalpaimore area, ,Ward No. 05,under Siliguri to verify the veracity of the information vide Siliguri PS GDE no. 42 dated 01.02.22. On reaching at 15.45 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the 80 up Country Spirit to locality without any valid documents as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. On searching - - i) 20 (Tweenty) sealed Bottles of 80 up Pet Himalayan Tuk Tuk country spirit

each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 50 each (Amounting of Rs 50/- x 20 =RS.1000/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list which was kept concealed in his temporary shop situated at Jalpaimore area, Ward No. 05, under Siliguri PS. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.55 hrs and 17.15 hrs. As such I arrested his U/S-41 Cr.P.C after observing all sorts of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Sadananda Barman (67 yrs) S/O Late Sudhir Barman of Patiramjote, Kalabusty near Radha Krishna Mandir, PS- Matigara, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
