Sir,

I, SI Uday Chakraborty of Siliguri P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely; (1) Pankaj Basak @ Toton (30 yrs) S/O Ram Basak of 1 no. Matangini Colony, ward no. 28, PS- Siliguri, Dist- Darjeeling, (2) Sanu Subba (21 yrs) @ Kanchha S/O Late Syam Subba of Tindhariya Chuna Bhati, PS- Kurseong, Dist- Darjeeling A/P Coal depot, PS- Siliguri, Dist- Darjeeling, (3) Pramit Mandal (23 yrs) S/O Late Netai Mandal of Ghughumali Fall Bazar, PS- Bhaktinagar, Dist- Jalpaiguri, (4) Nandu Tirkey (25 yrs) S/O Sawaroy Tirkey of Bagrakote near RailGate, Ward No. 18, PS- Siliguri, Dist- Darjeeling under arrest along with following seizure articles; (i) One (01) knife measuring approx. 12" including handle recovered from the possession of Pankaj Basak @ Toton (knife was on his hand) (ii) One iron rod measuring approx. 28" pointed at one end (seemed to be implement of house breaking) recovered from Sanu Subba (iii) One Knife (Sharp Cutting weapon) measuring approx. 12" including its handle recovered from the possession of Pramit Mandal, which he was holding on his hand, (iv) One house breaking Iron Rod measuring approx 18 "including handle recovered from the possession of Nandu Tirkey.

In this regard, I beg to report that on 02.02.22 at 01:15 hrs received secret reliable source information that about 12/13 anti socials being armed with deadly weapons assembled at River Bed of Mahananda Lal Mohan Mollick Ghat under Siliguri PS for making preparation to commit dacoity at Mahakalpally area. I informed this source information to IC Siliguri PS and noted the information vide Siliguri PS GDE No. 71 Dated. 02.02.22. As per the direction of IC Siliguri PS, at 01.25 hrs, I along with ASI Siben Sarkar, ASI Barun Kumar Dey, ASI Dhruva Mishra, C/971 Sanjay Roy, CV/283 Prosenjit Dey, CV-622 Ramanath Barman left for River Bed of Mahananda Lal Mohan Mollick Ghat under Siliguri PS for working out the information vide Siliguri GDE No. 72 dated 02.02.22 after briefing officers and force properly and also along with required papers / articles. At 01.35 around hrs we reached at near River Bed of Mahananda Lal Mohan Mollick Ghat under Siliguri PS and kept our vehicle at considerable distance near Airview more area. Then, I along with Officers and force headed towards River Bed of Mahananda Lal Mohan Mollick Ghat under Siliguri PS looking for witnesses, if any on the way and found nothing. By this time we reached at River Bed of Mahananda Lal Mohan Mollick Ghat under Siliguri PS, as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted four persons could be apprehended and

detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 7/8 others assembled at the spot making preparation to commit dacoity tonight at Mahakalpally area. I accordingly searched them in presence of witnesses and found ; (i) One (01) knife measuring approx. 12" including handle recovered from the possession of Pankaj Basak @ Toton (knife was on his hand) (ii) One iron rod measuring approx. 28" pointed at one end (seemed to be implement of house breaking) recovered from Sanu Subba (iii) One Knife (Sharp Cutting weapon) measuring approx. 12" including its handle recovered from the possession of Primit Mandal, which he was holding on his hand, (iv) One house breaking Iron Rod measuring approx 18 "including handle recovered from the possession of Nandu Tirkey which he was holding on his hand were making preparation for committing Dacoity tonight in Mahakalpally area but others managed to escape from the spot. Accordingly, I seized above noted weapons in presence of above mentioned witnesses under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 02.35 hrs to 04.45 hrs dated 02.02.2022. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in Mahakalpally area, but others managed to escape from the spot.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity at Mahakalpally area.

Further, it to mention here that the arrested accused persons are well known anti social and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons & others 7/8 others who fled away, under proper section of law and to cause its investigation.
