Sir,

In producing herewith arrested accused person namely Arjun Mahato (58 yrs) S/O Late Laxmi Mahato of Ganganagar, Monibaba road near Kali Mandir, Ward No. 05, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 15 (fifteen) sealed Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 15 =RS.1800/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list.

I, ASI Dhruba Misra of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Arjun Mahato (58 yrs) S/O Late Laxmi Mahato of Ganganagar, Monibaba road near Kali Mandir, Ward No. 05, PS- Siliguri, Dist- Darjeeling to the effect that on 04.02.22 at 18.15 hrs acting on secret source information that the above noted person was busy to sale Id liquor illegally at his temporary shop situated at Jalpaimore, under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 222 dated 04.02.22 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Siben Sarkar, CV-283 Prosenjit Dey and CV-662 Ramanth Barman left for Jalpaimore area under Siliguri to verify the veracity of the information vide Siliguri PS GDE no. 223 dated 04.02.22. On reaching at 18.35 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up Country Spirit to locality without any valid documents as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. On searching - i) 15 (fifteen) sealed Bottles of Himalayan Gold 60 up country spirit each containing

600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 15 =RS.1800/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list which was kept concealed in his temporary shop situated at Jalpaimore area under Siliguri PS. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 18.55 hrs and 20.15 hrs. As such I arrested his U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Arjun Mahato (58 yrs) S/O Late Laxmi Mahato of Ganganagar, Monibaba road near Kali Mandir, Ward No. 05, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
