Sir,

I, ASI Niranjan Sarkar presently posted at Khalpara TOP under PS. Siliguri SPC. In producing here with the following seized articles Viz:

1) 10 (TEN) Plastic made bottle of HIMALAYAN GOLD 60°UP COUNTRY SPIRIT. Each bottle contain 600 MI, marked MRP - 120/- without any valid document totalling an amount of 1200/-

I, ASI Niranjan Sarkar of Khalpara TOP, SLG. PS, SPC do hereby lodge ther complaint against the one absconded accused person named Sumitra Singh (F/55) W/O. Lt. Saral Singh of Vivekananda Road, Bora Patty, near Soni Mandir, Ward No. 08 PS. SLG Dist. DJG. to the effect that on 04/02/2022 at 12.55 hrs during K-27 Patrolling Van Duty vide Khalpara TOP GDE No. 91, Dt. 04/02/22, I received a source information that one Lady namely Sumitra Singh has been selling illegal liquor in her residence at Borapatty Vivekananda Road Ward No. 08. There was a further complaint that due to sale of liquor the peaceful environment of the locality has been deteriorated and it is very difficult for local people to live due to antisocial activities of the dunkers, who take drinks in the house of the accused person. After sharing the information with my officer in-charge and as per her direction and after briefing the matter to my force and LCV/1058. Pratima Chhetri. Subsequently, I along with officers and force reached at Bora Patty and as showing by the source I conducted raid at the house of the accused person and on being search found the above noted articles kept in her house compound without any valid permission or licence and was selling the same. Seeing the Police personnel the said accused escaped from the Place, no one came to produce any Cash memo of the said liquor and also unable to produce any legal documents in support of possession of above noted sprite. On 04/02/2022 from 13.25 hrs to 13.45 hrs I seized the illegal liquor from the house of the accused Sumitra Singha duly signed by the witness.

I therefore for pray before your honour to take charge of the seized articles and specific case start against the absconded accused named Sumitra Singh (F/55) W/O. Lt. Saral Singh of Vivekananda Road, Bora Patty, near Soni Mandir, Ward No. 08 PS. SLG Dist. DJG. under proper section of law.
