Sir,

In producing herewith arrested accused person namely Md Zabir Ali (35 yrs) S/O Md Kurban Ali of Debidanga, Middle Palash, PS- Prodhian Nagar, Dist- Darjeeling along with the following seized articles as per seizure list viz -

- i) One transparent Plastic Zipper Packet contains 190 (one hundred ninety) grams said to be Brown Sugar which was kept in inner side of black color trouser pant of the above noted person Marked as Exhibit-A.
- ii) 05 (five) grams of said to be Brown Sugar is taken out from Exhibits-A as sample for examination and report marked as Exhibit-A1.
- iii) One transparent Plastic Zipper Packet contains 80 (eighty) grams said to be Brown Sugar which was kept in inner side of black color trouser pant of the above noted person Marked as Exhibit-B.
- iv) 05 (five) grams of said to be Brown Sugar is taken out from Exhibits-A as sample for examination and report marked as Exhibit-B1.
- v) One Scooty ( Suzuki Access-125) bearing no. WB74AY9895 marked as Exhibit-C.

I, SI Uday Chakraborty of Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against Md Zabir Ali (35 yrs) S/O Md Kurban Ali of Debidanga, Middle Palash, PS- Prodhian Nagar, Dist- Darjeeling to the effect that on today (05.02.22) at 18.05 hrs received a specific source information that one person was sitting in a scooty bearing no. WB74AY9895 at Kanchanjangha Stadium in front of Swimming Pool under Siliguri PS along with huge quantity of Brown Sugar in his possession at present. The matter has been diarized vide Siliguri PS GDE No. 275 dated 05.02.22. Accordingly, I informed the matter to Sri. Sudip Chakraborty, Inspector-in-Charge, Siliguri Police Station, SPC in writing a letter to him and expressed the entire information, accordingly he directed to me to work out the information immediately, so at 18.25 hrs as per his kind direction myself along with ASI Siben Sarkar, ASI Subir Sen, ASI Dhruba Misra, CV-283 Prasenjit Dey and CV/622 Ramanath Barman all of Siliguri Police Station, Siliguri Police Commissionerate left for Kanchanjangha Stadium in front of Swimming Pool under Siliguri PS to verify the veracity of the information vide M C C.395/22 No. Dt. 05.02.22 which refers to GDE No. 276 Dt. 05.02.22 by Govt. Vehicle No. WB 61A0137 driven by CV/285 Krishna Yadav.

At the time of departure from PS, I took investigation kit including envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc. At about 18.40 hrs we reached at nearby Kanchanjangha Stadium in front of Swimming Pool under Siliguri PS. In the meanwhile I called two independent witnesses namely (1) Surajit Banerjee @ Boro Bhim (37 yrs) S/O Atul Banerjee of Subhashpally Lachubagan, Ward No. 18, PS- Siliguri, Dist. Darjeeling and (2) Ratan Das (33 yrs) S/O Tarun Das of do. disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. As per identification by source I found that the above noted person was sitting in his said scooty (WB74AY9895) and then we managed to cordon the said Scooty. After disclosing our identity, we detained the above noted person with strong reason to believe that he is illegally carrying Brown Sugar in his possession in conceal manner for supplying/ selling the same in Siliguri area for his wrongful gain. On being asked he disclosed his identity as noted above and admitted that he possessed Brown Sugar. I then gave him option whether he wanted to be searched in presence of Executive Magistrate or any Gazetted Police Officer. He agreed to be searched by one of them. Further, I served him option notice in accordance with provisions of law in this regard in writing and he also gave his approval of being searched by any one in writing in the notice served to him. Then I informed the matter to I.C. PS. So I requested him to come at Kanchanjangha Stadium in

regard in writing and he also gave his approval of being searched by any one in writing in the notice served to him. Then I informed the matter to I.C. PS. So I requested him to come at Kanchanjangha Stadium in front of Swimming Pool, Siliguri to remain present and supervise the search, seizure and label as he being a gazetted Police Officer. Accordingly, at 19.35 hrs, Sri Sudip Chakraborty, I. C. PS arrived at the spot in uniform and disclosed his identity to the detained person as well as witnesses as a Gazetted Police Officer. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But they refused to search the police party. Under supervision of Sri Sudip Chakraborty, Inspector-in-charge, of Siliguri Police Station, SPC and in presence of two independent and dis-interested public witnesses, searched the above noted detained person following all formalities keeping his decency and but nothing could be recovered on his person except wearing apparels and recovered two transparent Plastic Zipper Packet contains 190 grams and 80 grams respectively said to be Brown Sugar which was kept in inner side of black color trouser pant of the above noted person which was carried by him in his exclusively possession.

Then detained person confessed in presence of gazetted Police Officer that he was carrying these two packets in conceal manner for selling/supplying in different agent at Siliguri and adjacent area. On demand in presence of the Gazetted Police Officer Sri Sudip Chakraborty, I. C. PS they failed to produce any valid document in support of possessing of the Brown Sugar which was kept in inner side of black color trouser pant of the above noted person. On being asked he further confessed in presence of Gazatted Police Officer and other witnesses that he procured the same clandestinely from Biswas colony under Matigara PS area for the purpose of selling to his designed Customers in order to earn huge amount of money for his wrongful gain. On interrogation he disclosed that he has been dealing in such illegal drug trafficking business for the last 02 years and selling the same to the adjacent area of Siliguri. On examination of the alleged apprehended person regarding any documents for carrying / possessing of said brown sugar, he failed to produced any documents or license in support of possessing of such drugs. Then I seized the articles under proper seizure list and label under the supervision of Shri Sudip Chakraborty, I/C Siliguri PS in presence of witnesses duly signed by them as well as accused person and marked the seized exhibits as noted above. I also taken out sample from the mother packet for examination and report. The whole search, seizure & label was made in between 19.55 hrs and 22.05 hrs. Then I arrested the above noted accused person after observing all guidelines of Apex court of arrest, as he violated the terms and condition of Narcotic Drugs for possessing Brown Sugar without any valid authority & license.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely Md Zabir Ali (35 yrs) S/O Md Kurban Ali of Debidanga, Middle Palash, PS- Prophan Nagar, Dist- Darjeeling and arrange for its investigation.
