
I am ABULLA WAHAB S/O Md Abdul Hamid

i) That one Muslim marriage was solemnized

on 08.10.2021 as the present on witnesses,
voluntarily and without any coercion from any
side.

ii) that on 08.02.22 the family members of my

when I want to her home, her family member
threatened me with dire consequences that
they will kill me if I come again to their
house to take my wife.
