I SI Dilip Kr Paul of Pradhan Nagar PS, SPC do hereby lodge this written complaint against above noted 02 (two) accused persons to the effect that on 07.02.22 night during my van mobile duty I received an information of control room, SPC that DJ music playing loudly at Utpal Nagar under PS-Pradhan Nagar. Accordingly I informed to you and as per you direction I along with force had been to Utpal Nagar to know the veracity whether the loud music is been played or not. I reached at the spot on 08.02.2022 at about 01.05 hrs night and found that the DJ music is played loudly at Utpal nagar. Local people are annoying with the sound at late night. Having no other alternative I seized above sound system under proper seizure list and arrested 02 persons for violating lawful order and brought them at PS.

Under the above circumstances, I pray a specific case may kindly be stated against arrested 02 accd persons namely (1) Bittu Bhagat (26yrs), S/o-Murli Bhagat of Samar Nagar near Tribal School, PS-Pradhan Nagar, Dist-Darjeeling, (2) Prasant Choudhury (26yrs), S/o-Ranbir Choudhury of Naya Bazar, Dakshin Palash, PS-Pradhan Nagar, Dist-Darjeeling under proper section of law and arrange for its investigation.
