Pradhannagar, District Darjeeling would like to lodge this written complaint against the above named persons who are all residents of the same locality where I reside to the effect that on 7/02/2022 at about 10.30 pm in the night, the above named persons along with 30 others, all residents of Damragram, P.O. Gulma, P.S. Pradhannagar, District Darjeeling assaulted my brothers, namely Sri. Md Jamsar Ali and Sri. Md Samsar Ali, both sons of Md. Najrul, residents of Damragram, P.O. Gulma, P.S. Pradhannagar, District Darjeeling on the way with talwars, bamboo sticks, hockey sticks, motorcycle chain without any reason when my brothers were coming home in their vehicle (Alto) bearing WB 74 BE 9246 as a result of which both of my brothers have sustained injuries on their person and presently they both are admitted at Siliguri District Hospital, Siliguri, District Darjeeling. Sir, both of my brothers have sustained head injuries and spinal injuries and injuries on various parts of their body.

Sir, I further would like to state that the above persons have attempted to murder my brothers yesterday and at present my brothers are in serious conditions in the hospital and are still under treatment at Siliguri District Hospital, Siliguri, and District Darjeeling. Sir, I therefore request your kindness to take strict legal action against the above culprits and arrest the above named persons and others at its earliest and put them behind bars.
