Sir,

In producing here with six arrested accused persons 1) Sarfaraj Hossain (18) s/o Firoj Alam of Sonapurhat, vill Chital Ghata Po-Sonarpur, PS-Chopra, Dist- Uttar Dinajpur, 2) Sanjan Mohammad (27) s/o md. Israil of Sonapurhat, vill Chital Ghata Po-Sonarpur, PS-Chopra, Dist- Uttar Dinajpur, 3) Samsul Hoque (45) s/o Lt. Abdul Rahaman of Anandamoy Colony, Champasari, PS-Pradhan Nagar, Dist-Darjeeling, 4) Choton Kumar Sha @ jibon (31) s/o Lt. Ramchandra sha of Hariya Patti, Champasari, PS-pradhan Nagar, Dist-Darjeeling, 5) Santu Oraon (31) s/o Lt. Etoa Oraon of Hariya Patti, Champasari, PS-pradhan Nagar, Dist-Darjeeling, 6) Raj Rajput (21) s/o Krishna Rajput of Motipur monu, Ps-Motipurmona Dist-mujaffarpur, Bihar, arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to inform you that on 08.02.2022 while performing patrolling van duty vide Pradhan Nagar PS GDE No-316 Dated 08.02.2022 received information that some persons were loitering without wearing mask at Darjeeling More area. I along with C/207 Niladri Sarkar and C/ 230 Pradip Roy had been to Darjeeling More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41 Cr.P.C in between 21:35 hrs to 21:50 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
