When the truck reached the first destination at Hisua, Bihar the said party informed us that there were only 80 cartoons in the vehicle and the balance stock was missing.

We assume that the stocks have been misappropriated enroute and thus we request you to lodge a F.I.R. on the above matter so that the stolen goods can be recovered and the guilty be booked.
