In producing herewith four (04) arrested accused persons namely (i) Prakash Sahani (18), S/O Lal Babu Sahani of Rana Nagar, PS-MTG, Dist- DJG, (ii) Buddha Deb Roy (18), S/O Arabinda Roy of Patiramjote, PS-MTG, Dist- DJG, (iii) Raj Das (26), S/O Arun Das of Shivmandir, PS - MTG, Dist- DJG, (iv) Bijay Sahani (26), S/O Ganesh Sahani of Dry fish market, PS - MTG, Dist- DJG arrested u/s 41 Cr.P.C.

I, SI Md. Sanaullah of Matigara PS SPC to the effect that on 11.02.2022 while performing SPL Mobile duty under Matigara PS area found four persons namely (i) Prakash Sahani (18), S/O Lal Babu Sahani of Rana Nagar, PS-MTG, Dist- DJG, (ii) Buddha Deb Roy (18), S/O Arabinda Roy of Patiramjote, PS-MTG, Dist- DJG, (iii) Raj Das (26), S/O Arun Das of Shivmandir, PS - MTG, Dist- DJG, (iv) Bijay Sahani (26), S/O Ganesh Sahani of Dry fish market, PS - MTG, Dist- DJG were loitering near City Centre under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely (i) Prakash Sahani (18), S/O Lal Babu Sahani of Rana Nagar, PS-MTG, Dist- DJG, (ii) Buddha Deb Roy (18), S/O Arabinda Roy of Patiramjote, PS-MTG, Dist- DJG, (iii) Raj Das (26), S/O Arun Das of Shivmandir, PS - MTG, Dist- DJG, (iv) Bijay Sahani (26), S/O Ganesh Sahani of Dry fish market, PS - MTG, Dist- DJG under proper section of law and arrange for its investigation.
