Sir, it is pertinent to say that I ~~am~~ have 9 (nine) months pregnancy and I am afraid that my child in my abdomen have received severe injury and their intention was to kill me & my unborn child. I immediately shifted to Siliguri Distt. Hospital and treated myself there.

So, please take necessary action against the above named alleged persons.
