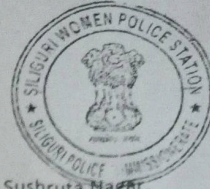

Subject : Written Complaint



Madam,

I, Smt. Renu Roy, wife of Sri Rabi Roy, resident of Kawakhali Township, P.O. – Sushruta Nagar, P.S. – Matigara, District - Darjeeling would like to bring the following facts to your kind notice –

- 1) That the following persons, namely, 1) Sri Dilip Roy, Son of Sri Dinesh Roy, resident of Kawakhali Township, P.O. – Sushruta Nagar, P.S. – Matigara, District - Darjeeling, 2) Sri Rajib Roy, Son of Sri Rabi Roy, resident of Bhutki Hat, Rajganj, District – Jalpaiguri, 3) Sri Dilip Roy, husband of Ramita Roy, 4) Ramita Roy, wife of Dilip Roy, No. 3 & 4 both resident of Kurani Para, P.S. – Kotwali, District – Jalpaiguri have been continuously torturing me physically and mentally since long pressuring me to leave the house as they do not like me for the reasons best known to them.
- 2) That on 08/04/2021 the above named persons in the absence of my husband attacked me with khukri and brutally beaten me and broke my nose which resulted in heavy bleeding. Hearing my scream my neighbors rushed to my house and saved me from them. Immediately I went to North Bengal Medical College and Hospital and got myself treated.
- 3) That till now I feel pain in my nose and got a permanent scar there.
- 4) That since then due to their torture I have started suffering from psychiatric problem. Now whenever they torture me mentally and physically it triggers psychiatric problem. It triggers anxiety, Sleeplessness, panic ect. In me. Presently I am consulting psychiatrists Dr. Shantanu De and Dr. Bera. I have got medical documents regarding this.
- 5) On 02/02/2022 the above-named accused persons again threatened me to leave the house and abused me in filthy language and shouted at me. This again triggered psychiatric problem in me and they done it intentionally knowing my condition. I had to go to psychiatrists again for this on 03/02/2022.
- 6) That the above named persons have made my life hell. They want me to die and continuously conspiring in that direction.
- 7) That today at 7 P.M. the above named person conspired to pick up a quarrel with me and switched off the electric pump to fill up the water tank after their tank was filled. The arrangement is such that after their tank is filled water flows to our tank. Then when I protested, the above-named persons assaulted me brutally. They kicked and punched me in my hands, legs and back. I am feeling severe pain in these parts of my body.

I, therefore, request you to be kind enough to treat this written complaint as F.I.R., arrest the above-named culprits immediately and take legal action against them and save my life.
