Sir,

With due respect, I am producing herewith one arrested accused person namely Mangal Malo(20) S/O- Lt. Kanu Malo of Shantipara near Madhab Mandir, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 19 (Nineteen) bottles of 60 Up Himalayan Gold Country Spirit containing 600 MI in each bottle.

I, SI Samik Paul presently attached with NJP PS under your kind control beg to state that today i.e. on 05.02.22 at 18.35 hrs I received a secret source information that one person namely Mangal Malo(20years) S/O-Kanu Malo of Shantipara near Madhab Mandir, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his house situated at Shantipara near Madhab Mandir, NJP. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No-186 dated 05.02.22 and informed the fact to you. As per your kind direction and instruction myself along with CV/116 Rohit Kumar Mahata, CV/824-Niru Kumar Yadav and others all of NJP PS, SPC left for Shantipara near Madhab Mandir to work out the information in hand. At about 18.55 hrs we arrived at the house of accused Mangal Malo(20) S/O-Kanu Malo of Shantipara near Madhab Mandir, PS- NJP, Dist.- Jalpaiguri and being identified by the source I held rald at the said house and managed to apprehended of the owner said house. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 18.55 hrs 19.20 hrs on 05.02.22.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Mangal Malo(20) S/O-Kanu Malo of Shantipara near Madhab Mandir, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
