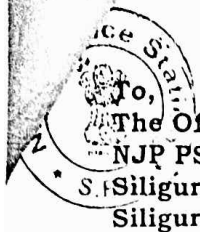

Sir,

With due respect, I am producing herewith 01 (One) arrested accused person namely Babon @ Biswajit Sutradhar (22 yrs) S/O Sunil Sutradhar of South Shanti Nagar, Near Housing, PS- NJP, Dist- Jalpaiguri under arrest and 01 improvised small Fire arm (One shooter) measuring 24 cm in length including its 13 CM barrel with one trigger, striking hammer, striking pin in working condition loaded with 01 (one) round live ammunition. The ground of arrest duly been communicated with him.

I SI Goutam Mallik of NJP PS, SPC do hereby lodge this written complaint against the above noted arrested accused person. In this regard, I beg to report that today i.e. on 05.02.22 at 18.05 hrs I received a secret information that one Babon of South Shanti Nagar under PS NJP, Dist.- Jalpaiguri is moving at Housing ground under PS- NJP, Dist.- Jalpaiguri with improvised fire arms loaded with live ammunition most probably for committing heinous crime. Accordingly, I Diarised the information in General diary vide NJP PS GDE No 183 dated 05.02.2022 and informed the fact to you. As per kind order and direction myself along with ASI Khagen Barman, ASI Sajal Das, C/1053 Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy all of NJP PS, SPC left for Housing ground, South Shanti Nagar under PS-NJP, Dist.- Jalpaiguri with investigation kit to work out the information in hand by Govt. vehicle. We reached at the spot i.e. South Shanti Nagar Housing Ground at about 18.45 hrs and as indicated by the source we able to apprehend one person. On being asked he disclosed his identity as noted above. As per source information, that he possessed improvised fire arms and ammunition. Hence, immediately I searched the detained person and found 01 (one) small Fire arm (One shooter) measuring 27 CM in length with one trigger, striking hammer, striking pin loaded with one live ammunition which accused kept consealed in his waist. He exclusively possessed improvised fire arm loaded with live ammunition illegally. On demand he failed to produce any document in support the said improvised fire arm and live ammunition which has been found in his possession. Thus when his involvement in carrying and possessing illegal fire arm and live ammunition was established, I seized that improvised fire arms and 01 (one) round of live ammunition under proper seizure list duly signed by him as well as by available witnesses between 19.45 hrs to 20.35 hrs on 05.02.22 and arrested him by preparing memo of arrest informing him about the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the said accused person namely Babon @ Biswajit Sutradhar (22 yrs) S/O Sunil Sutradhar of South Shanti Nagar, Near Housing, PS- NJP, Dist- Jalpaiguri is desperate and dangerous in nature, as he was carrying the said fire arm and ammunition with an objective to commit heinous crime in the locality.

As he willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Babon @ Biswajit Sutradhar (22 yrs) S/O Sunil Sutradhar of South Shanti Nagar, Near Housing, PS- NJP, Dist- Jalpaiguri under appropriate section of law and arrange for its investigation.
