I, Bhagabati Saha, w/o - Sri. Suvendu Saha, R/o -
Mangal Singh, P.O. Hatighishra, P.S. Naxal Bari, Dist -
Darjeeling would like to bring into your notice
that one Bhanu Saha, s/o - Hiratal Saha, R/o -
Bhujyapani, P.O. & P.S. Bagdogra, Dist - Darjeeling was
known to me for last one year through one
Tharen Roy, s/o - Ratan Roy, & Mangal Singh, P.O.
Hatighishra, P.S. Naxal Bari, Dist - Darjeeling.

Due to some financial crises, said Bhanu
Saha approach to me for some financial help,
considering the good relation I gave a sum of
Rs. 10,00,000/- (Rupees ten lakh) to said Bhanu
Saha on 29.10.2021 without any interest and
he promised me that he will return the said
amount within one month, but unfortunately
he was not able to pay the said amount
back and asked same time.

On 27.12.2021 said Bhanu saha issued a cheque in my favour and told me to incash the said amount within one month.

Thereafter I deposited the said cheque at S.B.I. Naralkari Branch, but unfortunately it was dishonoured with the reason found by sufficient. Consequently the abovenamed persons manhandled me on 26/01/2022 and I filed a case at Bagdogra P.S. BE in Bagdogra P.S. No. 67/22.

dt. 27/1/22 Due to the above mentioned reason today at 1:30 pm I came to the court to file a case against the said Bhanu saha and to my utter surprise I noticed that victor saha, s/o- Bhanu saha, Sampa Saha, w/o- Bhanu saha, and modhumita saha, daughter of Bhanu saha, was already present in the court gate and they stopped me from entering the court gate.

Thereafter I protested the said victor saha Sampa saha and modhumita saha, but they assaulted me and use filthy language, they forcefully tried to snatch my file from my hand which contain the said cheque, Agreement and documents required to file the case. Somehow I manage to restrain from such activity but said victor saha pushed me and disrobe and outrage my modesty.

with intervention of local people they manage to flee from the spot. But they have warned me if I file the case against them they will kill me and my family.

Therefore I request you to look into the matter and take proper step against said Victor Saha, Bhanu Saha, Sampasaha and modhumita Saha for their illegal activity.
