Sir,

In producing herewith the arrested accused person namely; Gourango Sarkar (54 yrs) S/O Late Abhinash Sarkar of Subhashpally, Lichubagan, Ward No. 18, PS- Siliguri, Dist- Darjeeling along with seized articles seized from the possession of the above noted accused person viz :- (a) 02(two) nos. of counting numbers Notebook , ii) 02 pair of Playing cards, iii) 02 (two) nos. of ball pen, iv) Cash RS 1060/- (One thousand sixty only) as board money, (v) one plastic made sheet as per seizure list,

I, SI Uday Chakraborty of Siliguri PS lodged a written complaint against Gourango Sarkar (54 yrs) S/O Late Abhinash Sarkar of Subhashpally, Lichubagan, Ward No. 18, PS- Siliguri, Dist- Darjeeling that on 11.02.22 at 22.05 hrs received an information from secret source that one digit and gambling with cards and counting Note books is going in the house of above noted accused person situated at Subhashpally, Lichubagan under PS-Siliguri, Dist- Darjeeling and the fact was diarized vide Siliguri PS GDE no. 648 dt 11.02.22. The matter was accordingly informed to I.C of Siliguri PS and being directed by him, I along with ASI Siben Sarkar, ASI Subir Sen, CV/283 Prosenjit Dey, CV/622 Ramanath Barman left for Subhashpally, Lichubagan under Siliguri PS to work out the information vide Siliguri PS G.D.E No. 649 dated 11.02.22. At 22.25 hrs after reaching there and prior to the entering inside the house of above noted accused person, we summoned two available witnesses namely 1) Md Sarafat (22) S/O Md Idrish Master of Tikiapara, Mazdoor Colony, Ward No.28, PS- Siliguri, Dist- Darjeeling 2) Manjit Singh (30 yrs) S/O Ranjit Singh of Medical Kawakhali , PS- Matigara, Dist- Darjeeling and requested them to be present with us during raid and cordoning the said place being identified by the source with a strong reason to believe that a illegal gambling and one digit is going in the house of the above noted accused person and Then we found that the above noted arrested person and others were gambling (one digit) with the help of playing cards two nos. of counting note book and money for wrongful gain and wrongful loss to each other inside the above mentioned house and managed to apprehend him. On interrogation he disclosed his identity as noted above. On further interrogation he confessed his guilt and stated that he along with Ajoy Sarkar and others jointly run their illegal gambling and One Digit with the help of Playing Cards, some note books and money for their wrongful gain and wrongful loss. But somehow, Ajay Sarkar and others managed to flew away from the spot.

I therefore, I pray before your kind end to start a specific case against the arrested accused person Gourango Sarkar (54 yrs) S/O Late Abhinash Sarkar of Subhashpally, Lichubagan, Ward No. 18, PS- Siliguri, Dist- Darjeeling and other accused persons namely Ajay Sarkar and others who managed to flee from the spot under proper section of law.


