Sir,

I, NANDITA BISWAS, wife of Tapan Biswas, daughter of Biren Majumder, resident of Bagrakot, Subhaspally, w/No. 20 under S.M.C, P.O. + P.S. Siliguri, Dist. Darjeeling, would like to inform you that as follows:-

i) That I had solemnized one Hindu marriage with TAPAN BISWAS, S/o Tarangya Biswas on 30.01.2005, and out of our wed. lock relation one female child and one male child took birth.

ii) That since our marriage my husband regularly tortured me physically and mentally on drunken condition. He always demands money and golden ornaments and on my refusal he assaults me on my person by anything in his hands. I tolerated all these years with a hope of that he will change his nature and character one day but in vain.

iii) That on 11.02.22 at about 5.30 P.M., my husband on a drunken condition, severely assaulted me and my daughter namely TANIA BISWAS with fists, kicks and iron rod on me and my daughters persons, without any reason, with an intention to kill us. He uttered slang, filthy and offensive languages upon me and my daughter. He assaulted with one "FRYING PAN" as a result the ring-finger of my right hand has been broken. We were rescued by the help of my neighbours. Afterwards my parents arrived my house to rescue me but he then assaulted my father and brother and threatened to kill them in short time. Now I we took shelter at my paternal house.

I therefore, request you to kindly take necessary legal steps against my husband and save us from his hands and thus obliged.
