SUB:- FIR against Sri Suren Singh resident of Tiranga More, Siliguri for unauthorized access to the property of WBSSEDCL resulting into damaging of fittings & Cradle Guard.

Sir,

I, Sri Subhadeep Banerjee S/O Sri Debasish Banerjee posted as Divisional Engineer, Siliguri Town Division, WBSSEDCL would like to lodge a complaint against Sri Suren Singha (Mob- 8918932008) resident of Tiranga More, Siliguri, Dist- Jalpaiguri who was cutting down tree in close proximity of our 33 KV HT Overhead line (Siliguri-Rabindranagar) on 11.02.2022. He was cutting the tree branch very close to our line without giving any information to us & not even performing the act with safety. As a result the tree branch fell over our line & our Cradle Guard - safety device got snapped along with felling of the branch. The incident occurred on 11.02.2022 at about 10:14 Hrs, when Siliguri-Rabindranagar tripped due to Earth Fault from Siliguri GSS. The line was charged at 10:16 Hrs & it stood ok.

As the CG snapped from the pole it fell on the road & got entangled with a bike, & the biker fell down from the bike sustaining minor injuries. The name of the biker who sustained injury is Sagar Mehta (Mob: 8956375197) staying at Apartment- Green Escape Flat-L2. Performing such unauthorized activity in such close vicinity of the power line is totally unacceptable. On occurrence of the incident the locals informed HT gang of Siliguri Sub Station as well as Rabindranagar Sub Station who reached the site & found out the fact as stated above.
