

Sir

I Sri Prashanta Baidya, son of Late Dinesh Baidya, resident of Nivedita Road, Niranjannagar, SMC Ward No. 36, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri. do hereby beg to state you as follows:

1. That I am the brother of Partha Baidya (Shanu), who is the candidate of BJP of Ward No. 36 of SMC, and I am his election agent.
2. That yesterday i.e. on 12/02/2022 at about 5:30 pm when my brother went to Shantinagar Bow Bazar Primary School to see the position of the election booth situated therein, he found that the cadres of TMC Party captured the booth and they were involved in vote rigging.
3. That my brother finding this situation tried to take photographs of the same, as evidence of the rigging (Chhappa vote) that was being done by the TMC Party cadres in presence of Sri Ranjan Shil Sharma, candidate of TMC.
4. That said Ranjan Shil Sharma pushed my brother, snatched the mobile phone of my brother and threw it on the ground with the intention to break it to destroy the evidence. Thereafter said Ranjan Shil Sharma along with his poling agent of Booth No. 218, Sri Kartik Barman, and other TMC goons namely Chanchal Chakraborty, Samir Biswas, Tapash Roy Choudhury, Santu Sarkar, Arjun (Haran), Bappa Pandit, Biman, Sanjay Sarkar, Mithu Banerjee, Biplab Das, Ganesh Dey, Sujit Sarkar, Madhabi Paul, Tapas Das (Kala), Shantimay Sarkar, Sujit Basak, Ranajit Paul, Mani Choudhury, Sunil alongwith other 50 to 60 unknown miscreants gathered therein, thereafter they blindly hit my brother with fists and blows thereafter when my brother fell on the ground, then said Samir Biswas tried to strangulated him with the help of a muffler with the intention to kill him and Ranjan Shil Sharma hit on his with a baton.
5. The TMC goons also snatched the gold chain, two gold rings and money purse alongwith cash of Rs. 3,580/-
6. This whole incident happened in the presence of the concerned poling officer of the said booth, the poling agents of other parties and two to three police personnel.



7. Thereafter somehow he was saved from getting killed by the intervention of those police personnel and media personnel who came to cover the said incident.
8. Thereafter my brother was rushed to Siliguri Hospital and he sustained various injuries on his body and presently he is admitted in Sanjivani Nuro Multi Speciality Hospital.
9. Even now said Ranjan Shil Sharma is terrorising the BJP supporters of our area by saying that he will ruin my brother and threatening us with dare consequences.

Under such circumstances you are hereby requested to kindly treat this as an FIR, put the wrong doers behind the bar and register specific criminal case against them under the appropriate sections of law.
