I, Suman Sengupta, Son Of Ashoke Sengupta, Assistant Engineer & Station Manager, Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India, would like to lodge a complaint regarding damage of electric lines and property of WBSIEDCL. At Around 14:30 hrs on 07/02.2022 afternoon Power House Customer Care Center received information regarding damage of electric lines in Khudiram Colony, near Kanchan Dairy, Bhaktinagar P.S, Siliguri. On reaching the site, the maintenance van of Power House Customer Care Center found that one Electric Pole was broken and other damages to the Electric Lines were caused which are the property of WBSIEDCL. On further enquiry on site, some locals informed that, a Truck vehicle having last nos 8532 which had come to unload cement in the near by Dalmia cement godown had caused the damage. The total damages caused by the vehicle is approximately around Rs 25690/- (Rupees Twenty Five Thousand Six Hundred And Ninty Only). One person having Ph no 7001337510 had contacted our office, claiming to be looking after the depot where the truck that caused the damage stations.

Thus you are requested to kindly initiate an investigation against the vehicle under Section 139 of the Electricity act 2003 amended on 2007 of India.
