I beg most respectfully state that I Sri Mahendra Prasad Sah @ Sri Mahendra Gupta, son of Late Ramekwal Sah, presently residing at Chittranjan, Quarter No. 3A, Shreet No. 63, P.O. & P.S. Chittranjan, Dist-Burdwan, have a joint property measuring 15 decimal at Mouza Khopalash, R.S. Plot No. 167 corresponding to L.R. Plot Nos. 117, 119, and 116 in L.R. Khatians being Nos. 114, 115, 136, J.L. No. 21, Police Station Matigara, District Darjeeling under Patharghata Gram Panchayat recorded in my name and also in the name of my two brothers namely Yogendra Prasad Sah @ Yogendra Gupta, son of Late Ramekwal Sah, resident of Rasulpur, Post Office Sain, Police Station Vaishali, District Vaishali, Bihar and Mahesh Prasad Sah @ Mahesh Gupta, son of Late Ramekwal Sah, resident of Premganj, Post Office and Police Station Lalganj, District Vaishali, Bihar. At present I and my brother Yogendra Prasad Sah is living out of Siliguri and taking advantage of this my another brother namely Mahesh Prasad Sah @ Mahesh Gupta fraudulently prepared a false Gift Deed in favour of his son namely Saurav Kumar.
