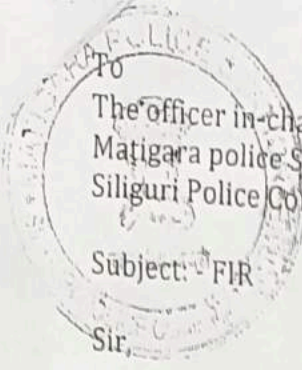

Kazimuddin of Gurung Busty, PS- PDN, Dist- DJG, (iii) Gobind Meheta (21), S/O Sambhu Maheta of Naya bazaar, SF Road, PS - Siliguri, Dist- Darjeeling arrested u/s 41 Cr.P.C.

I, SI Md. Sanaullah of Matigara PS SPC to the effect that on 13.02.2022 while performing SPL Mobile duty under Matigara PS area found Three persons namely (i) Khokon Barman (38), S/O Budharam Barman of Matigara, New Colony, PS - MTG, Dist- DJG, (ii) Amrul Khan (19), S/O Md. Kazimuddin of Gurung Busty, PS- PDN, Dist- DJG, (iii) Gobind Meheta (21), S/O Sambhu Maheta of Naya bazaar, SF Road, PS - Siliguri, Dist- Darjeeling were loitering near City Centre under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt.
