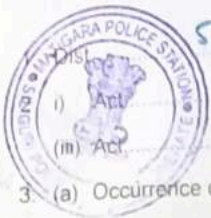

In producing herewith two (02) arrested accused persons namely (i) Saiful Khandokar (25), S/O Saidul Kahndokar of Dinhata, PS - Dinhata, Dist- CBR, (ii) Sushanta kr. Roy (30), S/O lt. Debendra Ch. Roy of Alipurduar, PS - APD, Dist- APD arrested u/s 41 Cr.P.C.

I, SI Paresh Barman of Matigara PS SPC to the effect that on 14.02.2022 while performing SPL Mobile duty under Matigara PS area found Two persons namely (i) Saiful Khandokar (25), S/O Saidul Kahndokar of Dinhata, PS - Dinhata, Dist- CBR, (ii) Sushanta kr. Roy (30), S/O lt. Debendra Ch. Roy of Alipurduar, PS - APD, Dist- APD were loitering near City Centre under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.753/XV II-ISS/2M 22/2020 Date-02.01.2022.
